#### **IRS Imposter Scams**

IRS imposter scams occur when someone contacts you pretending to work for the IRS. The imposter may contact you by phone, email, postal mail, or even a text message.

- Beware if someone calls claiming to be from the IRS. The IRS will always contact you by mail before calling about unpaid taxes.

 Ask the caller to provide their name, badge number, and callback number. Then call the Treasury Inspector General for Tax
Administration (TIGTA) to find out if the caller is an IRS employee with a legitimate reason to contact you.

- Be suspicious of threats. The IRS won't threaten to have police arrest you for not paying a bill.

- Don't give in to demands to pay money immediately. Don't click on any links in emails or text messages to verify your information.

Key Things to Know About Gap Insurance



Gap insurance pays for the difference between what a totaled car is worth and what the driver still owes on their auto loan.

Drivers should consider getting Gap insurance if they finance 100% or more of the purchase price, do not have a large down payment, their car depreciates quickly, or have negative equity in their trade.

#### **ben•e•fi•ci•ar•y** A person or entity named or

identified in account records to inherit the account.

Have you named your beneficiary? Is your designation up-to-date? Have you considered a secondary beneficiary?

It is important to officially designate, and update as needed, the person(s) you want to inherit your account in the event of your death.

#### Who Can Be a Beneficiary?

You're in charge when it comes to naming a beneficiary for your account. You can even designate multiple beneficiaries to a single account and select the percentage each person receives.

What Rights Does a Beneficiary Have?

Your account will operate just as it did prior to designating a beneficiary. A beneficiary has no rights to your property until after you pass.

How Do I Designate a Beneficiary?

Contact your local Success Credit Union branch to add a beneficiary to your account. Be sure to have the beneficiary's social security number or date of birth.
